New/updated table views:

- CO2 injection table is now available under *CO2 storage*. This table shows monthly CO2 volumes injected per licence and per well.
- New table *Blocks*, showing blocks and licences per field, now available as a table view under menu item *Field*.
- Tag changes in certain tables. See FactMaps release notes.

New/updated page views:

- Predrill entry and completion dates now available for *exploration* and *other wellbores*.
- In the menu structure, *Wellbore* → *Page View* → *Development* → *Drilling*, menu item *Drilling* has been changed to *Ongoing activity*.
- *Development wellbores* with status *ONLINE/OPERATIONAL* where drilling has not been reported as complete, can now be found under *Ongoing activity* (formerly menu item *Drilling*, see previous bullet point).

New data service:

- A new data service is now available through Sodir's REST API. The API data service is intended to replace the current FactPages data download options, so we encourage users of scheduled FactPage data downloads to test the new data service and make an early transition to the new service. The data service contains all our public data. Feedback is welcome at factweb@sodir.no. Updated page views:

- Maps now visible for wellbores categorized as type *other*.
- *Status* column now visible for all wellbore types on *field* and *licence* page views.
- *Content* column now visible for development wellbores on *licence* page views.

- Fixed an issue where some links between page views for **wellbores** reclassified from *exploration* to *development* were faulty

Updated page views:

- All **discovery**, **field** and **licence** page views now exclude wellbores never drilled (no listed entry date) from their respective wellbore sections
- **Licence** — If a production licence:
 - o was partitioned from, or
 - o is additional acreage toanother licence, this information now appears in the *general information* section of the licence's page view

Updated table views:

- **Licence** overview table now includes information about licences that are
 - o partitioned from, or
 - o additional acreage toother licences

Bugfixes:

- Corrected issue where stated file size units meant file size was incorrect by a factor of 1000
- Now consistently using the correct acronym for *carbon capture and storage* (CCS)
- Corrected **wellbore** page view sorting

Updated page views:

- **Wellbore** page views now show row *Production licence for drilling target* in cases where the wellbore's end point is located in a different licence than the starting point.
- **Discovery** page views now show row *Recources included in* in cases where the discovery's resources are included in a "parent" discovery.
- **Field**: *Owner*, *operator* and *licensee* history added to page views for fields

New table views:

- **Survey**: For survey categories *seismic*, *electromagnetic* and *other*, new table views have been added for survey with statuses *pending*, *paused* and *finished*

Updated table views:

- **Licence**: Added column *Main area*, displaying the relevant marginal sea, to the table *Licence*→*Table view*→*Work obligations/conditions* (tag: *prlMainArea*)
- **Survey**: Column *Legal basis* added to table *Survey*→*Table view*→*Overview surveys* (tag: *seaLawCategory*)
- **Company**: Added eight columns stating companies' roles as current/former operators/partners of *Transportation and Utilization Facilities* (TUF) and *Business Arrangement Areas* (BAA). (tags: *cmpTufOperCurrent*, *cmpTufOperFormer*, *cmpTufPartnerCurrent*, *cmpTufPartnerFormer*, *cmpBsnsArrAreaOperCurrent*, *cmpBsnsArrAreaOperFormer*, *cmpBsnsArrAreaPartnerCurrent*, *cmpBsnsArrAreaPartnerFormer*)
